And The Bids will be opened in the presence of bidder's representatives who choose to attend at 13:00 hrs on 2075/03/28 at the office of Modi Rural Municipality, Patichaur, Parbat. Documents received after deadline shall not be accepted.
5. All bids shall be accompanied by a valid bid security of an amount as shown in the table below. The bid security guarantee and required documents shall confirm to the standard format as specified in the bid document. The bid security guarantee issued by Commercial Bank approved by Nepal Rastra Bank shall be accepted by the employer.
6. Bid Security shall be valid for a period of 90 days after the deadline for bid submission date.
7. If the specified last date of bid document purchasing and submission/ opening falls on a Government holiday then the same time on the next working day shall be considered for such events. However, the last date for bid submission and opening shall be the next working day after the last date of bid purchasing. In such case the validity of bid security shall be considered from already specified last date for bid submission.
8. All government rules and regulations shall be according to Procurement act of Nepal. The Office of **MRM, Patichaur, Parbat** reserves right to accept or reject wholly or partly any or all the bids without assigning any reason, whatsoever.
