Bids will be opened immediately after the bid submission deadline in the presence of the bidders' representatives who choose to attend in person at office of MRM, Parbat.
5. All bids shall be accompanied by a valid bid security amount as shown in the below table. The bid security guarantee and required documents shall conform to the standard format as specified in the bid document. The bid security guarantee issued by Commercial Bank approved by Nepal Rastra Bank shall be accepted by the employer.
6. Bid Security shall be valid for a period of 45 days after the deadline for bid submission date.
8. If the specified date for last date of bid document purchasing and submission/ opening falls on a Government holiday then the same time on the next working day shall be considered for such events.
