1. **The Government of Nepal (GoN)** has allocated TB-SWAp funds to Modi Rural Municipality for **Trail Bridge Program** and the Rural Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders/Fabricators.
2. The Modi Rural Municipality invites Online Sealed Quotation from registered fabricators/bidders for supply of fabricated steel parts for Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Bid Documents. Total Estimated cost is 19,33,364.39 rupees(including VAT & Contingency).
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridge within last five years are eligible for the bidding. New fabricators may also apply in joint venture with an eligible fabricator having the required experience. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the minimum requirements. 5. Interested Bidders should submit online bids through e-procurement portal before 12:00pm, 11/06/2021. Bidders are required to follow the electronic bid submission procedure as specified in e-GP System Guideline 2073 and User manuals issued by PPMO which are available in e-GP system.
6. The Sealed Quotation will be opened in the presence of bidder's representatives who choose to attend at 14:00 hrs on 11<sup>th</sup> June, 2021 at the office of Modi Rural Municipality, Patichour, Parbat, Documents received after deadline shall not be accepted.
7. All Sealed Quotation shall be accompanied by a valid bid security amount of Rs 50,000.00 in given bank details which shall be valid for minimum of 75 days from the day of notice publication. The bid security guarantee and required documents shall confirm to the standard format as specified in the bid document. The bid security guarantee issued by Class A Commercial Bank approved by Nepal Rastra Bank shall be accepted by the employer.
